

SUMMARY ANNUAL REPORT FOR EMPLOYER SOLUTIONS STAFFING GROUP

This is a summary of the annual report of the Employer Solutions Staffing Group plan, a dental, vision, temporary disability, long-term disability, life insurance, accident, critical illness and AD&D plan (Employer Identification Number 20-2301006, Plan Number 503), for the plan year 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has an insurance contract with The Guardian Life Insurance Company of America to pay certain dental, vision, temporary disability, long-term disability, life insurance, accident, critical illness and AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$198,104.
